Cryptocurrency Panel

2017 saw Bitcoin rise from 900 to 20,000 a 21x increase only to drop to below 7,000 by February 2018. 2017 also saw the emergence of new cryptocurrencies, ICOs as an alternative to venture capital and the furtherance of the blockchain as a secure distributed application platform disrupting many industries.
